BIOGRAPHY

Prospective presenters have to submit their biography in not more than 50 words. It should be written in English or Malay.

ABSTRACT

Prospective presenters are invited to submit their abstract according to the following guidelines:

- It should not exceed 500 words (double spaced)
- It should be submitted electronically as MS Word.
- Title of the paper should not exceed 15 words
- Provides name of author(s) and affiliation(s), and resident country of author(s)
- Includes full mailing and email addresses of the author(s)
- Must include main keywords.

FULL PAPER

To ensure that the papers can be reproduced without any difficulties, all submission should be prepared according to the following guidelines:

- Only electronic submission to the Organizing Committee will be accepted.
- Any complete manuscripts must be in the form of MS Word files and it should not be in the compressed form (e.g. a zip file).
- The size of the MS Word file must be less than 2.0 megabytes (M bytes).
- Font: 12 Times New Roman, 1.0 Spacing.
- The maximum paper length is 15 pages.
